

Phantom Ninjas ("Phantom Ninjas", "we," or "us") is committed to protecting your privacy. Our Privacy Policy explains how we collect, use, disclose, and protect information about you or associated with you ("personal information"), and your choices about the collection and use of your information. This Privacy Policy applies to the online services offered by Phantom Ninjas at https://mccombsn8.WIXsite.com/greyschool. Note: GreySchool is a service that is only offered to residents of the U.S.

### What Information Do We Collect?

We collect information in two different ways: directly and automatically.

- Directly: You can browse our site without providing personal information, but you must register in order to access most of the features of our Service. We ask for certain information such as your username, email address, date of birth and password when you create an account, or if you correspond with us.
- **Automatically:** We automatically collect certain types of usage information when you visit our website or use our Service. When you visit the Site, we may send one or more cookies (see "Do We Use Tracking Technologies?" section of this Policy for more information) to your computer that uniquely identifies your browser and lets us help you log in faster and enhance your navigation through the site. A cookie may also convey information to us about how you use the Service (e.g. the pages you view, the links you click, and other actions you take on the Service) and allow us to track your usage of the Service over time.
  - We may collect log file information from your browser or mobile device each time you access the Service. Log file information may include anonymous information such as your web request, Internet Protocol ("IP") address, browser type, information about your mobile device, referring / exit pages and URLs, number of clicks and how you interact with links on the Service, domain names, landing pages, pages viewed, and other such information.
  - o When you access our Services by or through a mobile device, we may receive or collect and store a unique identification numbers associated with your device ("Device ID"), mobile carrier, device type and manufacturer, phone number, and, depending on your mobile device settings, your geographical location data,

including GPS coordinates (e.g. latitude and/or longitude) or similar information regarding the location of your mobile device.

## **Your Choices Regarding Your Information**

- **Profile data.** You can change your profile settings by visiting "Edit My Account" on our site to control whether your profile can be seen by other GreySchool members.
- **Data Retention.** We do not retain your information (see "How Do We Store Information?" below).

## For What Purpose Do We Collect the Information?

We use the information we collect to operate, maintain, and provide to you the features and functionality of the Service, as well as to communicate directly with you, such as to send you email messages. We may also send you Service-related emails (e.g. account verification, change or updates to features of the Service, technical and security notices). You may not opt-out of Service-related e-mails. #### **How Do We Store Information?**

We host our Site on WIX, a website hosting platform. Therefore, the information we collect is not hosted on our site. However, WIX has a Privacy Policy that governs their methods of storing your information, which can be found at https://www.WIX.com/about/privacy.

# **How Long Do We Store Your Information?**

We host our Site on WIX, a website hosting platform. Therefore, the information we collect is not hosted on our site. However, WIX has a Privacy Policy that governs the length of time during which they store your information, which can be found at https://www.WIX.com/about/privacy.

#### With Whom Do We Share Information?

We do not share your information with any third parties. However, WIX has a Privacy Policy that governs their interaction with third parties and what information they share. That Policy can be found at https://www.WIX.com/about/privacy. Further, we do not sell, trade, or rent your

information to others. However, we will disclose your information if we believe in good faith that it is required by law, or to protect public safety.

## Do We Use Third Party Links?

Our website contains links to other sites (Twitter, Facebook, etc.), which may contain advertising and other content. We do not control the content or links that appear on these sites and are not responsible for the privacy practices employed by websites linked to or from our website.

# Do We Protect Children's Privacy?

Our intended audience has a reasonable likelihood of containing children that are under 13 years of age. The Children's Online Privacy and Protection Act ("COPPA") requires that online service providers obtain clear and verifiable parental consent before receiving personal information from children under 13. Thus, when we collect information on a child who is under the age of 13, we take additional steps to protect children's privacy, including:

- Notifying parents about our information practices with regard to children, including the types of personal information we may collect from children, the uses to which we may put that information, and whether and with whom we may share that information
- In accordance with applicable law, obtaining consent from parents for the collection of personal information from their children, or for sending information about our products and services directly to their children
- Limiting our collection of personal information from children to no more than is reasonably necessary to participate in an online activity
- Giving parents access or the ability to request access to personal information we have collected from their children and the ability to request that the personal information be changed or deleted

# Do We Use Tracking Technologies?

In order for our website's technologies to work properly, a small data file ("cookie") must be downloaded and stored on your device. By default, we use several persistent cookies for purposes of session and user authentication, security, keeping the User's preferences (e.g., regarding default language and settings), connection stability, monitoring performance of our services and marketing campaigns, and generally providing and improving our Services.

If you want to delete or block any cookies, please refer to the help and support area on your internet browser for instructions on how to locate the file or directory that stores cookies.
